Section 4. First-Aid Measures

Eye Contact: Flush eyes with plenty of water for 15 minutes. If irritation develops, consult a physician.

Storage Conditions: Store in a cool, dry, well-ventilated area away from heat, ignition sources, and direct sunlight. Always keep containers tightly closed.
